Computing log returns and annualized volatility

Abstract

This note computes **log returns**, annualized **volatility**, and visualizes the distribution for a liquid asset.

Definitions

Given a price series P_t , the **log return** is:

$$r_t = \ln \left(\frac{P_t}{P_{t-1}} \right)$$

Annualized volatility (assuming 252 trading days):

$$\sigma_{\text{ann}} = \sqrt{252} \cdot \text{std}(r_t)$$

Compute (Python)
